Data Collection

- For each visitor to our Web page, our Web server automatically recognizes only the consumer's domain name, but not the e-mail address (where possible).

- Aggregate (not individual) information on what pages consumers access or visit.
- Information volunteered by the consumer, such as newsletter subscriptions, survey information and/or site registrations.

Information Usage

- We do not share contact information with anyone except for the purposes of conducting Toro Consulting, Inc. business as noted below.
- We use external service providers to provide credit card and other payment mechanisms, and e-commerce capabilities.
